# LSV Awards of Excellence

This event held annually recognises and acknowledges the outstanding achievements, contribution, and commitment that our people make to their clubs, communities and LSV.

These achievements reflect LSV's purpose as a vital rescue, emergency, and community service organisation and emphasises our people's actions position the movement as a valued and beloved organisation across the state of Victoria.

State award winners will be nominated by the Honours and Awards Committee to represent LSV and Victoria; for Surf Life Saving Australia national awards, VicSport State awards and other relevant awards.

This section outlines each award and provides a description of the award, the selection criteria, due dates, selection processes and presentation.

Note: awards presented at the Awards of Excellence Evening may change year on year information will be provided in advance of the event.

## Recognition periods

The qualifying period is 1 May – 30 April annually, corresponding to the concluding patrolling season.

## Due dates

The awards have a specific due date to align with internal due dates and to comply with both internal and external schedules. Due dates have been selected to ensure nominations are appropriately and fairly considered and processed prior to the Awards of Excellence evening. The specific due dates will be advised each year as part of the circulated information on each award. Nominations received after the advertised closing date will not be considered.

## Nominations

- For the annual State Awards of Excellence, nominations will be called for annually.
- LSV members will be notified via club mail, circular, social media and advertised on the LSV website and Club Gateway.
- Personal details within the nomination form will be kept confidential and comply with LSV's privacy policy.
- LSV may use the information from the nomination to promote the award and recognise the winner/s utilising various media.

Note: Club Presidents will be notified of received nominations.

## Evaluation and scoring

Panels evaluating nominations will consist of at least 3 judges, where possible.

Notes and marking will be recorded via AwardForce by all panel members.

The judging panels adopt a scoring rubric, which can be applied to each of the criteria.

## Nomination Guidelines

The following section provides key information to consider and be aware of to assist you in your nominations.

- Each award has a set criterion, which must be addressed when completing the online nomination form.
- Please ensure you answer the specific questions within the nomination form.
- It is important to consider the criteria carefully when choosing a category to nominate for, noting nominators may seek advice from the Honours and Awards Committee or re prior to submitting.
- Please check the eligibility criteria prior to submitting.
- Online nomination forms must be submitted by the nominated due date:

Nominations may be submitted by a Club Committee, Club Member, Council Executive members or by an individual staff or volunteer member of LSV.

- Ensure you provide a high-quality photo with your nomination.
- Supporting documents e.g. qualifications, awards and digital photos are included in the nomination submitted to LSV.

## Nomination Guiding Principles

Nominees when compiling a nomination for the following Award Categories are encouraged to consider the following elements listed below which may assist in the nominations including completion of the nomination summary section.

**Important considerations:** when showcasing a member, you may want to consider the questions below to boost the quality of your nomination...

- What relevant positions, roles or responsibilities do they hold?
- Have they done something in response to an identified need or problem?
- Have they done something new or different to achieve results?
- Have they inspired others to think or to do things differently?
- Have they had to overcome any challenges to make a difference or achieve success?
- Do they model positive and supportive attitudes, behaviours and actions?

**Important considerations:** when showcasing the achievements of programs or innovations, you may want to consider the questions below to boost the quality of your nomination.

- What was the motivation or research which drove the program/innovation?
- What were the aims and objectives?
- What did it look like (location, duration, resources required etc.)?
- How was it evaluated to ensure it achieved its aims and objectives?
- Were there any challenges which needed to be overcome to achieve success?
- You may wish to attach photographs, include links to any promotional material created or media coverage received.

## 5 Major State Awards

### 5.1 LSV Life Membership

Life Saving Victoria Life membership recognises those individual members whose volunteering has rendered a distinguished, sustained, and conspicuous service to LSV over a period of at least fifteen (15) years.

---

#### Eligibility Criteria

Nominee must;

- Nominee must be a financial member of an affiliated lifesaving club.
- Nominee must be an LSV member of good standing.
- To be considered for Life Membership, a nominee must have rendered distinguished voluntary contribution/s to LSV as an elected/appointed State Officer.
- The nomination may be supported by the inclusion of distinguished voluntary contributions to SLSV or RLSSAV as an elected/appointed State Officer.
- The point of distinction to this recognition is the nature of the nominee's State level contribution to **LSV over a period of at least 15 years** which need not be continuous and sets the nominee apart and ahead of other members.
- For service to be considered distinguished it must comprise both a sustained and distinct contribution to LSV in concurrent service in two or more positions may only be counted once in determining the total period of service.
- Contributions at state level that can be classified as unique and attributed to that person in an individual capacity may be considered for the purposes of considering a member's nomination for Life Membership.

---

#### Interpretive criteria

**Note:** Club service may be considered within the nomination, should the nature of such service be of innovation and leading best practice and was provided to assist in the development of objectives of LSV.

- Will have maintained a sustained, conspicuous voluntary service as a State elected/appointed officer at a level that brings distinction to LSV.
  - Will have made an individual contribution as a State elected/appointed officer that can be classified as unique, and which can be attributed to that person as opposed to being a member of a wider group of members over a period of at least 15 years which need not be continuous.
  - The unique and distinguished nature of the contribution can be at different levels of LSV provided that the nomination details the exemplary and distinguished service which can be seen as a unique contribution to the advancement of the objectives of LSV and lifesaving in Victoria.

## Selection Criteria

Consider and address the following selection criteria.

### Service

What distinguishes this service beyond that of others?

### Contribution

1. What makes this person's State service contribution(s) unique amongst LSV membership?
2. What State service contribution(s) are directly attributable to this person (apart from others)?
3. How has this State Service contribution(s) advanced LSV's purpose and lifesaving across Victoria?

### Length of service

- Has this distinguished State service spanned at least 15 years (which may not be continuous).

---

## Nominations process and information

- Nominations can be submitted by a Club Committee, Club Member, Council Executive members or by an individual member of LSV using the online nomination form.
- Nominations received after the closing date will not be considered.
- Nominations lodged with the Honours and Awards Committee will be verified for accuracy of the details provided.
- The Honours and Awards Committee will consider all nominations for LSV Life Membership.
- The Honours and Awards Committee will provide a recommendation for Life Membership to the LSV Board. Successful recommendations will be recorded in the minutes of the relevant Board meeting.
- Life Memberships are awarded annually and will be presented at the LSV Awards of Excellence evening.
- Following the appointment to Life Membership the successful nominee will be informed and invited to the Awards of Excellence evening.
- Proposers will be contacted regarding success or non-success of their nomination, unsuccessful nominees will not be promoted nor contacted.
- There will be no feedback from the Honours and Awards Committee on any nomination.
- Unsuccessful nominations for LSV Life Membership may be resubmitted for consideration after two (2) years.

---

## Presentation of award

Life Member recipients will be announced at the LSV Awards of Excellence Evening.

---

## 5.2 President's Certificate

Life Saving Victoria's purpose is to save lives and empower communities to safely enjoy water. United by our shared vision, Together preventing drowning. Together thriving around water. The President's Certificate honours exceptional service that exemplifies dedication to water safety, community wellbeing and the values of Life Saving Victoria.

The President's Certificate will recognise and celebrate outstanding and significant service, action or contribution to LSV, lifesaving and the community that support, enhance or promote LSV's purpose. One or more Certificates may be awarded annually.

---

### Eligibility Criteria

Nominee may be;

- LSV members and employees of good standing
- Partner organisations
- Member of the public or an external organisation

---

### Selection Criteria

Consider and address the following selection criteria.

1. Contribution or service to LSV that can be considered unique or innovative in nature and noteworthy.
2. Conspicuous lifesaving action/s which warrant recognition.
3. Program, project or event which is of benefit to LSV, lifesaving and/or the community.
4. Actions, contributions or service that supports, enhances or promotes the LSV purpose and vision.

---

### Nominations process and information

- Nominations can be submitted during the calendar year by a Club Committee, Club Member, Council Executive members or by an individual member of LSV using the online form.
- All nominations will be considered by the Honours and Awards Committee and recommended to the LSV President for absolute decision.
- Nominations requiring supplementary information will be referred to the proposer.
- Honours and Awards Committee may seek clarification from across LSV to verify all or some of the statements/claims contained in the nomination.

---

### Presentation of award

President's Certificate recipients will be announced at the LSV Awards of Excellence Evening.

### 5.3 John Wishart Memorial Medal - Victorian Lifesaver of the Year

The John Wishart Memorial Medal Award recognises the LSV member who has made an outstanding contribution to the delivery of frontline lifesaving services as a patrolling lifesaver and who can be presented as an identifiable ambassador for Life Saving Victoria.



#### JOHN WISHART

This award perpetuates the memory and the deeds of John

Wishart of the Sorrento-Portsea Surf Life Saving Club who was taken by a shark at Portsea Beach in March 1956.

---

**Award qualifying period**                      The award qualification period is from: 1 May – 30 April annually.

---

**Eligibility Criteria**

Nominee must;

- Be a financial member of an affiliated lifesaving club.
  - Be an LSV member of good standing.
  - Hold a current SLSA Bronze Medallion
  - Have completed patrol hours for previous two seasons.
- 

**Selection Criteria**

Consider and address the following selection criteria.

1. Tell us about the member being nominated.
  2. What has been achieved?
  3. What impact has this had, and for whom?
- 

**Nomination Guidance**

For assistance, consider the Nomination Guiding Principles (pg. 13) and these prompts to assist in boosting the quality of responses to selection criteria.

- Patrolling Achievements – Key milestones and contributions during active patrols.
  - Leadership & Roles – Positions held at club and responsibilities related to patrolling.
  - Initiatives & Impact – Programs or improvements nominee introduced and their outcomes.
  - Skill Development & Recognition – Training, certifications, and awards gained in the past year.
  - Rescue & Community Engagement – Rescue experiences and involvement in lifesaving or water safety programs (including schools, CALD education, and emergency services).

---

**Nominations process and information**

- Nominations can be submitted by a Club Committee, Club Member, Council Executive members or by an individual member of LSV using the online nomination form.
- The relevant Club President will be notified of received nomination/s.
- Nominations must include copies of
  - patrol hours achieved during the qualifying period and the previous two (2) season.
  - SLSA patrol qualifications and awards
  - a digital photo of the nominee.
- Honours and Awards Committee may seek clarification from across LSV to verify all or some of statements/claims contained in the nomination.
- All nominations received will be considered by the Honours and Awards Committee and a short list of nominees will be compiled for interview.
- A maximum of five (5) nominees will be shortlisted to finalist.

---

**Finalist interview**

- Nominees short listed as finalists will be notified by email
- Finalists are required to attend an interview with members of the Honours & Awards Committee.
- Finalists will then be asked questions on the answers contained in the nomination and current/perceived challenges in their roles
- **Note:** There are to be no audio-visual aids used during the interview.

Award winner will be announced at the LSV Awards of Excellence Evening.

## 5.4 Graeme Long Memorial Medal - Volunteer of the Year

The Graeme Long Memorial Medal Award (Volunteer of the Year) recognises an individual's volunteer contribution which has significantly benefited their club or has enhanced the development of LSV's purpose and values throughout the past year.



### GRAEME LONG

This award perpetuates the memory and volunteer contributions of Graeme Long of the Bancoora Surf Life Saving Club. Graeme was lost at sea whilst paddling back to Torquay after conducting an examination at Anglesea in 1998.

- Nominations can be submitted by a Club Committee, Club Member, Council Executive members or by an individual member of LSV using the online nomination form.
- The relevant Club President will be notified of received nomination/s.
- Nominations must include:
  - copies of SLISA qualifications and awards
  - a digital photo of the nominee
- Honours and Awards Committee may seek clarification from across LSV to verify all or some of statements/claims contained in the nomination.
- All nominations received will be considered by the Honours and Awards Committee and a short list of nominees will be compiled for interview.

Sadly, in October 2021 Janet passed away. With this award we recognise her achievements, impact, and celebrate her immeasurable contribution to lifesaving and inclusion. She has made lifesaving better and her legacy will live on.

## 6.2 Ross and Andrew Powell Rescue Recognition Award

The Award honours an exceptional rescue performed in lifesaving and service delivery, evaluated against industry best practices and established operational standards.

### ROSS and ANDREW POWELL

This award is named in honour of Ross and Andrew Powell, father and son, and members of the Port Campbell Surf Life Saving Club. In April 2019, Ross and Andrew, alongside fellow members, responded to a rescue near the Sherbrook River in extremely dangerous conditions.



Tragically, Ross and Andrew lost their lives during the rescue attempt.

The award recognises outstanding rescue efforts and serves as a lasting tribute to the courage, selflessness, and commitment to saving lives shown by Ross and Andrew, and by lifesavers across Victoria.

## 11.3 State Service Award

The award acknowledges the contribution of a member who has held official positions in support of LSV efforts. This award will recognise those volunteers who have rendered service to Life Saving Victoria at a State level in the categories listed below for periods of 5/10/15/20/25+ years (5-year increments).

#### State Committee Members

- Members who have held position/s on a State Committee under the auspice of the LSV Board and Councils.

#### Council Appointed Panel Members or Volunteers

- Panel Members and/or Volunteers who have been appointed to State positions/s e.g. State Coach/Manager/Program Leaders/Officials under the auspice of LSV Councils as listed above).

### Nomination process and information

State Service Awards are nominated in two ways:

1. Submitted by an individual, LSV staff, council executive member/s or by an LSV State or Area Officer using an online nomination form, or
2. Automatically based on the LSV run reports, all records will be sent to the individual prior to awarding for verification.
3. All the nominations will be considered by the relevant Council Executive and respective LSV staff, along with HaAC for their submissions.

Mike Martin AM, Anglesea SLSC, LSV and SLSA Life Member, is the former President of LSV from 2006 - 2012 and was an integral in the merger of RLSSA-V and SLSV. Mike's awards, accolades and contribution list is long and distinguishes, including being awarded an Australian Commonwealth Honours for his outstanding service to lifesaving. Amongst many contributions, Mike is an incredible leader and supporter of youth in the lifesaving movement.

## 11.6 Maurie Rayner Scholarship

Maurie Rayner was a Torquay member, a champion athlete and, some of his feats included winning both State and Australian ski titles and placed 2<sup>nd</sup> in the first Victorian Ironman competition and was one of the early champions of the “surfathon” who went onto to hold State, National and World SLSA titles in various events.

The Maurie Rayner Scholarship was created in 2002 and has been awarded to outstanding athletes who are recognised by their sporting achievements throughout the season.

The Fred Westfield medal is awarded to the most outstanding U13 competitor for that season.

## 12 Surf Life Saving Australia

The purpose of these awards is to recognise and reward members who have made an outstanding contribution to the delivery and development of surf lifesaving activities.

### 12.1 General notes

- All nominees must be SLSA financial members (or affiliated organisations).
- Nominations should focus on activities during the 2025/2026 Surf Life Saving season, from 1st July 2025 – 30th June 2026.
- Where ages are mentioned, this refers to the members age as of 30 September in the 2025/2026 season.
- Winners may be called upon to act as ambassadors of Surf Life Saving, both within the organisation and to external audiences.
- Paid employees at any level may nominate for the awards listed. However, paid service will only be counted if nominating for the Lifeguard of the Year and Coach of the Year award – all other awards recognise voluntary contributions only.
- Unless otherwise specified, these awards are in recognition of individual achievements, (team submissions will not be considered).
- SLSA will accept one award from each State/Territory, per category to ensure the process is streamlined and transparent.
- LSV will submit nomination on behalf of Victorian members, winners of corresponding award from the LSV Awards of Excellence.

## 12.2 Australian Surf Life Saving National Awards

All finalists for the national award will go through a selection panel which will involve a review of applications.

Finalists for the 'Surf Lifesaver of the Year, Volunteer of the Year, Youth Surf Lifesaver of the Year and Club of the Year will be required to participate in a face-to-face interview or presentation (Club of the Year only); details of which will be available following the close of nominations. The selection panel will determine a winner from both a review of the application and the interview.

### Surf Lifesaver of the Year

An active patrolling member who has made an outstanding contribution to the delivery and development of surf lifesaving frontline services.

### Young Surf Lifesaver of the Year

An active patrolling member (between the ages of 15-21, this refers to the members age as at 30 September in the 2024/25 season) who has made an outstanding contribution to the delivery and development of surf lifesaving frontline services.

### Lifeguard of the Year

An Australian Lifeguard Service Lifeguard who has made an outstanding contribution to the delivery and development of lifeguard services.

### Volunteer of the Year

An impressive member who has made a difference through their volunteering efforts.

### Club of the Year

An outstanding SLS-affiliated club that is committed to improving the experience of its members, providing a safer environment for the community, and improving club operations.

### Athlete of the Year

An athlete aged 15 or older who has achieved sporting excellence in Open Aged Competition.

### Youth Athlete of the Year

An athlete aged between 15-18 (this refers to the members age as at 30 September in the 2025/2026 season) who has achieved sporting excellence in Youth and/or Open Aged Competition.

### Surf Sport Team of the Year

The 38th edition of Surf Sport Manual defines a team as an event that is contested by more than one competitor from the same club or lifesaving unit who may either complete an event or race together as a discrete unit (e.g., boat race, IRB race, surf teams, R&R etc.) or separately (e.g., relay events, board rescue etc.).

### **Coach of the Year**

An accredited coach who has made a significant contribution to athlete performance at a state, national and/or international level, to the development of athletes in SLS activities outside of surf sports, and to the educational development of other coaches in SLS.

### **Official of the Year**

An accredited surf sports official who has made a significant contribution to both officiating at a state, national and/international level, and to the educational development of other officials in SLS.

### **Trainer of the Year**

An endorsed Trainer who is passionate about building the skills of others, consistently delivers a positive learning experience, and who encourages other members to engage in the delivery of training.

### **Assessor of the Year**

An endorsed Assessor who is passionate about building the skills of others, consistently delivers a positive and supportive assessment experience, and who encourages other members to engage in training or assessment.

### **Young Volunteer of the Year**

The Young Volunteer of the Year recognises an exceptional member aged 15–21 who has contributed meaningfully through their volunteering efforts

## 12.3 Hall of Fame

The SLSA Hall of Fame is an integral part of recognising the achievements and efforts of members in the SLS movement. Hall of Fame permanently displays, commemorates, and recognises members and teams who have achieved outstanding accomplishments and exceptional contributions to the development of SLS in Australia.

### Eligibility Criteria

All nomination forms should be accompanied by the following supporting materials:

- a photograph of the nominee
- a conclusive history of the nominee (maximum of two pages)
- displayed exceptional service to surf lifesaving in the specific category.
- achieved outstanding individual or team accomplishments which sets the individual or team apart from other surf lifesavers or teams.
- displayed sustained excellence over a long period of time to the category for which they are nominated.
- endorsement by the club and sent to SLSA.

### Selection Criteria

Each award is allocated under the following categories:

#### Surf Lifesaving - Lifesaving

This category recognises those who have been involved in all facets of surf lifesaving operations. Examples are active patrolling, training, assessment, rescue services and the general support activities involved in beach patrols, search and rescue and surveillance.

#### Surf Lifesaving – Administration

This category recognises those involved in the purely administrative aspects of surf lifesaving. Examples are, but not limited to, club secretaries and treasurers. This category also includes surf sports officials.

## Surf Lifesaving – Sport

This category recognises those who have excelled in lifesaving sports and/or the coaching and training associated with lifesaving sports.

### Nominations

- Only current or past individual members of SLSA are eligible for induction into the SLSA Hall of Fame (Note: that nominations may be for eligible individual members or for teams of eligible members).
- Nominations not endorsed may only be resubmitted for consideration after a period of two (2) years.
- Nominations being resubmitted should be enhanced to meet the standard of the award.
- Nominations may only be for one category, however, evidence supporting the nomination covering activities relevant to other categories should be provided and will be taken into consideration.
- It is important that the complete career of the nominee is put forward to allow for a total assessment.
- Nominees are to be in good standing with SLSA.

## 12.4 SLSA Meritorious Awards

Meritorious Awards are awarded to affiliated clubs and/or their members and/or the public for outstanding deeds of bravery performed during lifesaving operations of Surf Life Saving Australia (SLSA) (during and outside of designated patrol hours).

### Nomination Submissions

All nominations for SLSA Meritorious Awards are to be submitted to the HaAC for consideration. Nomination approved by HaAC will be forwarded to the Board of Directors for endorsement.

### Nomination Guidelines

Nomination guidelines are documented in the annual SLSA Circular.

### Nomination Forms

All nominations must be submitted using the SLSA Meritorious Awards Nomination form.

### Categories

Meritorious Awards are established in two sections, Individual and Group or Club. Each category is divided into three grades, as follows:

#### **Meritorious Awards - Individual**

- **Silver Medallion**
  - Very high level of risk to rescuer combined with optimal application of skills and supporting systems. Outcome for patient/s without rescue attempt = Definite fatality.
- **Bronze Medallion**
  - High level of risk to rescuer combined with very good application of skills and supporting systems. Outcome for patient/s without rescue attempt = High chance of a fatality
- **Certificate of Merit**
  - Moderate level of risk to rescuer combined with good application of skills and supporting systems.
  - Outcome for patient/s without rescue attempt = Serious injury/possibility of a fatality.

## 12.5 Meritorious Awards – Group or Club

The Group or Club Award is issued for rescues of exceptional merit, in which a group of members are involved and where no individuals can be singled out for an award.

- **Certificate of Merit with Silver Medallion inset**
  - Very high level of risk to rescuer, combined with optimal application of skills and supporting systems. Outcome for patient/s without rescue attempt would have resulted in definite fatality.
- **Certificate of Merit with Bronze Medallion inset.**
  - High level of risk to rescuer, combined with very good application of skills and supporting systems. Outcome for patient/s without rescue attempt would have resulted in a high chance of a fatality.
- **Certificate of Merit**
  - Moderate level of risk to rescuer, combined with good application of skills and supporting systems. Outcome for patient/s without rescue attempt would have resulted in serious injury or possible fatality.

## 12.6 National Long Service Award

SLSA has long service awards to recognise members for their sustained contribution to SLS.

Members can apply for Service Certificates via the Forms tab in the [Members Hub](#). These long service awards are awarded for:

- 25 years Long Service
- 30 years Long Service
- 40 years Long Service
- 50 years Long Service
- 60 years Long Service
- 70 years Long Service
- 75 years Long Service

### Essential Criteria

- The award may be issued after the respective years' membership of SLSA
- Years of membership shall commence from the date of joining an affiliated club, or a ladies auxiliary or former junior surf lifesaving association, but not earlier than the age to become eligible to obtain SLSA Surf Rescue Certificate\*, whichever shall be the later date.
- Where the years of membership are not continuous, they shall be aggregated.
- The details of the members qualifying for the award shall include their bronze medallion number or proof of date of joining an affiliated club, ladies auxiliary or former junior surf lifesaving association.

## 13 International Life Saving Association

### 13.1 International Lifesaving Citation of Merit

The International Lifesaving (ILS) the minimum criteria for the ILS citation are:

- Any person who has contributed to the furtherance of lifesaving and the goals of ILS and of a manner of enduring global importance.
- As a member nation is SLISA has the responsibility of nominating and issuing ILS citations to its individual members in order to ensure that the members who deserve these awards are being appropriately recognised. SLISA has developed the following criteria and nomination timeline.

#### Eligibility Criteria

Please supply evidence where appropriate via either a printout from surf guard or equivalent.

The particular SLISA awards shall be automatically nominated for ILS citations:

- The recipient of a meritorious award and slash or commendation for bravery
- National winners of Surf Lifesaver, Volunteer and Lifeguard of the Year
- SLISA Life Members
- Individual winners of an SLISA Innovation award.

In addition to these automatic nominations, the following individuals should also be eligible:

- Members who have contributed to significant international projects and/or events or to national projects with an international significance should also be nominated for ILS citations
- These could include the capacity building programmes with developing nations educational tours, the conduct of sporting events etc, Sponsors, Donors and Politicians who have made a significant contribution to the growth and sustainability of SLISA.

#### LSV Nomination Information

- Nominations for SLISA Citation of Merit will be called for annually.
- Nominations received will be considered for endorsement by the HaAC

# COMMONWEALTH AWARDS

## 14 Australian Commonwealth Honours

The Australian Honours and Awards system recognises the outstanding service and contributions of Australians. Recipients come from right across the country and from all walks of life. While some are well-known, the majority are unsung heroes.

Whilst typically they haven't sought thanks or recognition, they deserve both. The Honours and Awards system gives the nation a chance to celebrate and acknowledge those who work tirelessly to improve local communities and to make Australia a better place.

### Nomination process

Any Australian can nominate someone for an award. Nominations are assessed by the Honours and Awards Secretariat, considered by the Council of the Order of Australia before recommendations are made to the Governor-General.

The Australian Honours and Awards system include:

- The Order of Australia
- Meritorious Awards
- Military Awards; and
- Bravery decorations.

Nominations may be made by the Honours and Awards Committee panel with endorsements of the LSV President and CEO for endorsement.

### Presentation

Award winners will be notified by the Official Secretary to the Governor-General, to accept the nomination for an award or appointment within the Australian honours system.

You may also be invited to attend an investiture ceremony at the Government House

This honour will be acknowledged at the LSV Awards of Excellence

## 15 Emergency Services Medal

Emergency Management Victoria awarding the Emergency Services Medal (ESM) twice per year for Kings birthday honours and Australia Day honours.

The AFSM and ESM were created to recognise those people in occupations that are inherently more hazardous than most others. Nominations need to include details of frontline service that the nominee is active in now, and also past service (within two years) with exposure to hazard. The achievements the nominee has made should be framed within their frontline service.

### Recognising diversity in Victoria's emergency services

Reflecting on national honour and award nominations, the Minister for Emergency Services continues to be an advocate for the commitment and the importance of increasing diversity and inclusion for women and members of diverse communities in Victoria's emergency services.

Emergency service organisations, with their strong ties to the community, have a unique opportunity to be the leaders in building a more diverse and inclusive Victoria.

The *Emergency Management Diversity and Inclusion Framework: Respect and Inclusion for All*, provides information on what diversity and inclusion means, why it is important and what needs to be done.

Nominators are strongly encouraged to consider the framework and diversity when making nominations for the AFSM and ESM, taking into consideration nominees that are a true representation of the community we serve.

### Eligibility criteria

Members should meet the following:

- Be serving /sworn members within the associated state emergency services and voluntary emergency organisations as defined in the State Emergency Management Plan.
- Be in occupations that primarily provide services to the community, particularly in times of emergency or disaster (policy advice has been that these occupations are inherently more hazardous than most others and these awards were established for this reason). I.e. 'frontline', 'boots on ground'.
- Have recent frontline service – within the last two years and be no more than 12 months since retirement.
- Be currently involved in frontline service with exposure to hazard, or o Be eligible members who formerly worked (within the last two years) on the frontline with prolonged exposure to hazard in the service of the community, and who are now using their frontline experience to provide training or education in support others on the frontline.

The ESM recognises distinguished service by members of emergency service organisations across Australia, and people who are involved in emergency management, training or education.

**Note:** Management or administrative personnel who have not had exposure to hazards during their career are not eligible. Other forms of recognition, including the Public Service Medal or the Order of Australia Awards may be more appropriate.
